Time to Revive Release and Waiver of Liability:: reviveINDIANA

This release and Waiver of Liability (the "Release") by the ("Participant") is in favor of the reviveINDIANA Campaign of Time to Revive, A Texas Corporation, a nonprofit corporation organized and existing under the laws of the State of Texas, USA, its directors, officers, employees, volunteer, and agents (collectively, "Time to Revive").

- I, the Participant, desire to volunteer with reviveINDIANA/Time to Revive to provide ministry services and engage in the activities related to offering these services. I understand that the activities may include, but are not limited to, travel to sites in the United States; transportation in commercial and reviveINDIANA/Time to Revive-owned vehicles; moving and lifting heavy objects; cooking and serving food; and working and inhabiting environments that may be without power, sanitation, or are otherwise in needed. I hereby freely and voluntarily, without duress, execute the Release under the following terms:
- **1.Waiver and Release**: I, the Participant release and forever discharge and hold harmless reviveINDIANA Campaign/Time to Revive from any claim or liability that I, the Participant, may have against reviveINDIANA Campaign/Time to Revive with respect to any bodily injury, personal injury, illness, death, or property damage that may result from my participation in a ministry operation. I also understand that reviveINDIANA/Time to Revive does not assume any responsibility or obligation to provide financial or other assistance, including, but not limited to medical, health, or disability insurance, in the event of injury, illness, death or property damage (insurance requirements below).
- **2.Insurance**: reviveINDIANA/Time to Revive does not carry or maintain, and expressly disclaims responsibility for providing any health, medical, or disability insurance coverage for the Participant. EACH PARTICIPANT IS EXPECTED AND ENCOURAGED TO CARRY PERSONAL LIABILITY OR HEALTH INSURANCE PRIOR TO REGISTERING AS A TIME TO REVIVE VOLUNTEER.
- **3.Medical Treatment**: Except as otherwise agreed to by reviveINDIANA/Time to Revive in writing, I hereby release and forever discharge reviveINDIANA/Time to Revive from any claim whatsoever that arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my time with reviveINDIANA/Time to Revive.
- **4.Assumption of Risk**: I understand that my time with reviveINDIANA/Time to Revive may include activities that may be hazardous to me, including, but not limited to, cook and food preparation activities, loading and unloading of heavy equipment and materials, transportation to and from the ministry site, and working in locations in need. I recognize and understand that my time with reviveINDIANA/Time to Revive may, in some situations, involve inherently dangerous activities. I hereby expressly and specifically assume the risk of injury or harm in these activities and release reviveINDIANA/Time to Revive from all liability for injury, illness, death, or property damage resulting from the activities of my time with reviveINDIANA/Time To Revive.
- **5.Photographic Release**: I grant and convey unto reviveINDIANA/Time to Revive all rights, title, and interest in any and all photographic images and video or audio recordings made by reviveINDIANA/Time to Revive during my work for reviveINDIANA/Time to Revive, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
- **6.Other**: I understand that it is my desire to further the work of reviveINDIANA/Time to Revive by performing services as a Volunteer, specifically as a Volunteer in ministry opportunities. I undertake to perform said services as a Volunteer without compensation and that, in performing said services, I acknowledge that I am not acting as an employee of reviveINDIANA/Time to Revive.
